DR. JAMES NOLT

Adjunct associate Professor at New York
University



Dr. Nolt has been a Senior Fellow at the World Policy Institute for 20 years. He recently completed a book, *International Political Economy: The Business of War and Peace*, published by Routledge Press. His core research interest is the influence of business, especially finance, on international relations. He has also published a number of articles about the Chinese military and the East Asian military balance. He is a regular reviewer for *Publishers Weekly* magazine. He has appeared on CBS News, CNN World News Asia, WebFN, the syndicated PBS program *Asian America*, and at conferences in East Asia. He has been interviewed on numerous radio programs, including *Newsweek on Air*, and across Canada on the CBC radio network. Dr. Nolt recently lived in China for 7 years as founding campus dean of a joint venture college and later associate professor of management there. He has also taught at the New School University, graduate and undergraduate faculty, Seton Hall University, and Vanderbilt University. He has a PhD in political science from the University of Chicago and an MA in economics from the University of Massachusetts at Amherst.

DEAN EDWARD HARRIS

Assistant Dean and Associate Professor for
International LL.M. programs at Chicago-Kent
College of Law



Dean Harris joined IIT Chicago-Kent in 2004 after working as an associate for Schuyler, Roche & Zwirner PC, where he concentrated on international business transactions, primarily in general corporate and intellectual property matters. His current research interests include international intellectual property issues and issues concerning private actors under international law. He also co-authored an article suggesting certain reforms to U.S. securities laws that was published in the Delaware Journal of Corporate Law. He received a B.A. from Loyola University Chicago and a J.D. with high honors from Chicago-Kent in 2001, where he also earned a certificate in The Program in International and Comparative Law. Dean Harris has clerked for the Attorney General of the State of Illinois, Environmental Bureau, and the United States Agency for International Development. He has also served as a legal extern for Federal Magistrate Judge Edward A. Bobrick. .

PROF. BARTRAM BROWN

Professor of Law and Co-Director of the Program in
International and Comparative Law.



Professor Brown is a member of the Council on Foreign Relations and serves on the Board of Directors of Amnesty International, USA. He is also a member of the Advisory Board of the American Bar Association's Central and Eastern European Law Initiative (CEELI). He served as a law clerk at the International Criminal Tribunal for the former Yugoslavia, and participated in the 1998 Rome Diplomatic Conference on the Establishment of an International Criminal Court as Legal Advisor to the Republic of Trinidad and Tobago. In 1999 and 2000, he was a public member of the United States Delegation to the United Nations Commission on Human Rights in Geneva, Switzerland. He has recently led or participated in human rights fact-finding missions to several countries including Haiti, Bahrain and Malawi. Professor Brown received his B.A. from Harvard University, his J.D. from Columbia University, and his Ph.D. from the Graduate Institute of International Studies in Geneva, Switzerland. At Columbia, he was managing editor of the Columbia Human Rights Law Review. He has published a book on the law and politics of the World Bank, as well as articles on international human rights law, international humanitarian law, international criminal tribunals, and international trade law.
